

LCAP Community Feedback Forum May 31, 2018 Questions from Community Stakeholders

What kind of training is provided for parent liaisons (parent liaison certificate)?

During the 16-17 and part of the 17-18 school year, parent liaisons were lead by a district parent liaison who provided regular collaboration and training opportunities among parent liaisons at the school sites. During the 18-19 school year, Student Services and Educational Services will work with principals to develop a targeted professional development plan for parent liaisons in alignment with LCAP goals and the parent liaison job description.

I would like to know the number of parents who responded from each school. Regarding survey. Only 11 parents submitted survey for Belle Air.

The LCAP Parent survey was administered in English and Spanish at all school sites during the month of December 2017 and January 2018. The total number of parent respondents was 396. Some parents who responded indicated that they had children enrolled at multiple sites. The following is a list of the number of parents who responded from each site:

Bring District notices to the school site website, newsletter and on site. Have parent liaisons begin to meld school and district goals and community

Part of our actions and services for Priority 3 goals surrounding Engagement involve developing systems of communication including transforming our website, development of a district calendar and targeted professional development for employees.

Parent liaisons - bring them into the school site council, make sure they have professional development is strong and liaisons are education and meet expectations School site council is an elected council that is composed of teachers, parents, a non-teaching staff member and the principal. Members are elected to the council by the stakeholder group they represent.

Articulate the current obstacles to reaching 60% in-classroom instruction target. Have a well planned, transparent plan to strive for higher percentage of staff salary.

Education Code 41372 established recommended percentages for the ratio of instructional salaries to total district expenditures, less medical health services, Non-Public Schools (NPS), Non-Public Agencies (NPA), food services and transportation. The recommendation was that elementary districts would have a 60% ratio, high school districts would have 50% and unified school districts would have 55%. In 2016-17, San Bruno fell short at approximately 53%. The district is currently in the negotiation process with the San Bruno Education Association (SBEA) in regard to salaries and benefits. This challenge is not unique to San Bruno Park School District. Over 40% of elementary school districts in California do not meet EC 41372.

Can the parent liaisons be requested to attend the SSC meetings?

School site council meetings are open to the entire school community. The SSC chairperson can request that the site parent liaison present and share updates regarding their work.

Otherwise, anyone may attend the SSC meetings as a guest unless elected by their own group of stakeholders for a voting position on SSC.

Communicate the Board meetings on school newsletters or calendars, possibly at school bulletin board; signage.

Board agendas are sent to school sites and posted a minimum of 72 hours in advance of regular board meetings.

What are examples of some of the enrichment opportunities for students?

A few examples of enrichment opportunities that are being considered include the creation of a Gifted and Talented Education Program, student participation in STEM activities, Spelling Bee, Odyssey of the Mind, Destination Learning, Science Fair, Art Fair, Music and Physical Education. The development of activities will be based upon interest and input from students and families.
